- Communicate between home and school through notices, newsletters, text, email and the school website.
- Provide safety guidance to your child prior to admitting them with regular reminders once they settle in.

Parent/Carer.....

To help my child at school, I know and understand that:

If my child becomes symptomatic and receives a positive test result, I will not send them to school for 7 days, and others in the household will self-isolate for 14 days as a family.

If concerned, I will get them tested and I will let the school know as soon as possible via telephone.

If my child shows symptoms of COVID-19 at school, I will collect my child from school immediately.

When dropping my child off and picking them up, I will adhere to social distancing rules, observing the routes marked out around the school.

When dropping off and picking up, I will strictly stick to the school timings for my child.

I will restrict the items moving between school and home to include only water bottles & reading books, additional stationary that children bring in will be left in school.

I agree to my child having their temperature taken on arrival and during the day if they feel or present as being unwell.

My child will need to use good respiratory and hand hygiene. I will remind them of the importance of this regularly.

I will not be allowed into the school without a pre-arranged appointment - make appointments via telephone or email.

I need to support all staff in their efforts to create an 'as safe as possible' environment.

I need to inform the school immediately of any changes to parents/carers and emergency contacts details. And will read all letters/messages/emails that are sent home.

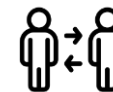

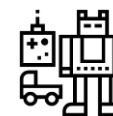
I will do my best to:
